ELIGIBILITY.** The promotion is open to people 13 years of age or older (as of the date of entry) residing in the 50 United States (excluding any jurisdiction where participation would be unlawful). Employees and immediate family members of employees of Logitech Inc., its affiliates, and its subsidiaries are not eligible. Winners of Monthly Prizes are eligible for the Grand Prize. If a prize is won by a minor, it will be awarded in the minor's behalf to the winner's parent or legal guardian who must sign all required acknowledgements and releases.

We are looking for your most hilarious, ridiculous and disastrous story. Keep it clean, Logitech doesn't accept any stories that contain unlawful, obscene, defamatory, libelous, threatening, pornographic, harassing, hateful, racially or ethnically offensive language.

#### **4. SELECTION OF WINNERS.**

Monthly Prizes. Three (3) monthly winners will be selected from the eligible entries received each month during the Promotion Period. There will be one monthly winner for the most hilarious story; a second monthly winner for the most ridiculous story; and a third monthly winner for the most disastrous story.
